FTLBC Board of Governors' Meeting Minutes

Regular Board Meeting Date – May 8, 2023

3:55 p.m. – Meeting called to order by President Knyvett Lee

Board members present: Treasurer Deborah Branch, President Knyvett Lee, Mark Yaeger and Secretary Daniel Tordella. Club members Allen Bozek, David Kupperman, Robin Kupperman, Alan Rubin, Barbara Tate and Rosemary Boden were also present for some or all of the meeting. Club Manager Emilio Lopez was also present.

- 1. <u>Treasurer's report</u>: Treasurer Deborah Branch reported:
 - a. In April 2023, FTLBC had a net operating loss of \$1,625. Year to date through 4/30/23, FTLBC has a net operating gain of \$3,289.
 - b. As of May 7, 2023, the FTLBC bank balance was \$57,293.
 - c. Board member Rick Shapiro continues to look into FTLBC's possible qualification for a federal employee retention credit (ERC).
- 2. <u>President's report</u>: President Lee reported:
 - a. January 2024 Bridge Cruise: The Board appointed Deborah Branch to be FTLBC's 2024 Cruise liaison and Daniel Tordella to be her back-up.
 - b. Minutes from the 4/10/23 FTLBC Board meeting were approved.
 - c. Appointment of Jonathan Salt to the FTLBC Board to replace resigned Board member John Albright was ratified / approved.
 - d. Discussion of how to promote "non-bridge" use of the FTLBC building and rates to be charged building was had.
 - e. Ambassador program (player available on site to play if needed) vs. partnership desk (players needing a partner) was discussed.
 - f. Swiss teams game for Sunday(s) is being considered. To help newer players understand the Swiss teams scoring, the limited mentor game for Friday June 18th is being planned as a Swiss teams event.
 - g. Possible benefit(s) and to whom of a barometer game was discussed.
 - h. Back-up / extra refrigerator: The consensus is that the Club needs one (that works properly); Daniel Tordella reported (following the Board meeting) that

3. Manager's Report: Club Manager Lopez reported:

- c. Mahjong has requested a "second tier" rate for attendees that don't play a full session.

- c. Grievance and Ethics Committee: There was only one minor incident for April 2023 that was handled informally by Allen Bozek. The Board greatly appreciates Allen's efforts.
