In Crockfords Cup, GCBA is guaranteed one representative in Round 3 as the 2 Cheltenham sides are set to play each other.


Gloucestershire also has one team through to the third round of the Gold Cup

AN ODDITY

When was the last time you made zero tricks playing in a doubled contract? Hopefully never! Well it didn't happen on this hand either but it might well have done. In a recent national knock-out match the following hand occurred.



The bidding started 2♣ from North and East, keen to disrupt proceedings, overcalled 2. This was doubled when it came round to North and subsequent redouble by West (who could not remember if 2 was natural or artificial) led to an inelegant contract of 2♥X. South led the ♣Q and continued the suit. North drew trumps. He then cashed all his black suit tricks but had to concede a diamond at the end. 7 down doubled cost 1700 nonvul. It might have been 2000 had South not killed his entry at trick 1 to his ultimately winning ten of spades. This failing still resulted in 15 IMPS to the NS pair. The offending pair will remain anonymous unless someone makes be a better offer than they did!

UNDERDOG TEAM TACTICS

Let's say you draw a seeded team in the Gold Cup. Realistically, you don't rate your chances of winning over 48 boards, so how should you approach the match? Larry Cohen – a top US player and

writer has the following tips in his most recent book. Firstly you must appreciate that:-

- The experience of playing against top class opposition is invaluable - something to learn from.
- The pressure is all on them. You are not expected to win and can therefore play in a more relaxed way. You are in a no-lose situation.

What about strategy?

Top teams pulp weaker players on part-score deals. Don't let this happen. Compete actively for partials. Don't sell out when opponents have stopped in a low-level fit as this risks losing 5-6 IMPs a time. It is fairly safe to get involved - they won't be keen to double you into game and you may push them around a bit. You can be slightly overactive in this area as your opponents probably expect it. I will cover more on this aspect of the game in a future article. If you can keep in contention in the match on the small deals, you are in with a chance if you get a bit lucky on a couple of big-swing deals.

At IMPs, you need to bid close games, and to stand a chance you must certainly do this, but an inferior team is very unlikely to win a long match with ordinary behaviour and luck, so how should you deviate your game to give you a fighting chance?

Don't go mad! That will most likely just end the match prematurely and you will learn nothing from the experience opportunity.

You need to look to make MINOR but REASONABLE deviations from the norm. Some examples:-

- With a high combined point count, perhaps look to play in 3NT rather than a known 4-4 major suit fit.
- Do something different to the other table – so against 1NT-3NT you might lead a heart from QJ9x rather than a spade from QJTx.
- Maybe pass a 12 count in first position which is sure to be opened at the other table.

Such actions stir things up a little and give you a chance to gain on pure luck, but clearly these actions slightly reduce your average outcome.

Take mildly against the odds actions. For example, bid a 50% grand slam. This would not normally be a good idea as opponents may stop in game but assuming that first class opponents will bid to slam, it is a chance to generate the sort of swing you need to win the match. Say you hold

♦K98532 **♥**5 **♦**AQJ54 **♣**A

You might bid

1 ♠ - 2N (Jacoby) - 4N - 5 ♠ and then 7 ♠ is a reasonable shot as it is at worst on the diamond finesse.

Another thing that you may be able to organise via your seating arrangements is to play a different strength 1NT opener to the other pair sitting your way. This creates different auctions, perhaps gets hands played from the other side and attracts different leads. Get lucky and you may pull off the upset of the year.
