Discussion included the number of tables required to ensure club financial stability and the awareness that guest participation online is unpredictable.

Further discussion around the benefits of club membership resulted in the decision that the Dennis Johnson team game would be at no cost for our 2024 club membership.

There is a need to formulate a plan for the disposition of items in our inventory which are no longer needed by our club. Initial efforts will focus on providing a list of items which are obviously past their best before date and arrange for disposal.

Future endeavours will identify items to be sold, offered to the membership or appropriately donated.

7. Compensation for the Club Treasurer

Previous Board policy provides for free plays for the treasurer. The current treasurer is providing 40 hours a month of financial expertise to the club exclusive of phone calls and regular bank deposits as well as volunteer hours. In light of this significant contribution and the fact that there has been no fee for services for the past 3 years the Board's unanimously passed a motion to provide current free plays and retroactive compensation from March 30 2023 based on previous unassigned free plays.




