ANNUAL MEETING

Selvin started with remarks for the Annual Meeting:

The State of the Club is strong since we are now debt free for the first time in over 6 years. Thanks to over 300 contributors, we were able to pay off the \$120,000 loan. Table counts continue to increase, especially with the 499ers coming back. For the month of January, NBC had the largest face-to-face table count in North America. Dave LeGrow was hired as Manager in September 2022. Barry Davis was named Volunteer of the Year in December 2022.

NEW BOARD MEMBERS

Welcome was given to Ellen Gabriel and Richard Loew as new members and to Melanie Schaengold for a new three-year term.

ELECTION OF OFFICIERS

Treasurer: Davis, nominated by Selvin, seconded by Vega; motion carried Secretary: Henry, nominated by Schaengold, seconded by Davis; motion carried

MINUTES

The minutes of the January 2023 BOG meeting were presented. Vega moved to accept the minutes; motion carried.

APPROVAL OF NEW MEMBERS

Henry presented a list of 9 new members who were approved.

ROGER BANKS SERVICE AWARD

John and Jean Shufelt were nominated for the Roger Banks Service Award for their leadership giving. Selvin will check with them to ensure they are willing to accept the award before an announcement is made.

LOAN PAYOFF UPDATE—Davis

• To date, over 300 people have donated to paying off our bank loan. These donations, along with the matching funds pledged by John and Jean Shufelt, have allowed us to pay off the loan.

ENTREPRENEURIAL TEACHING PROGRAM - Selvin/LeGrow

Teachers are responsible for writing description of the course and developing the materials. The curriculum must be presented to the Operation Manager for approval. Expectations include a sign-in sheet and a summary of \$\$ for each day; an evaluation form at the end of the course. Teacher sets the rates for the course with the proceeds being split 75:25 to the teacher: club. All checks and payments will be paid to Naples Bridge Center and then teachers will be paid 75% of collected funds at the end of each month.

Resolution to approve LeGrow's outline was made by Selvin, seconded by Gabriel; motion approved with stipulation that the outline be placed in the Byelaws through the normal process.

MANAGER'S REPORT—LeGrow

- LeGrow submitted a written report.
- There was discussion about several items:
 - --We will use duplicate boards in the Thursday night Swiss teams' game to speed up the process. Additionally, this has the advantage of the availability of hand records for the boards.
 - --Five members completed the Club Director's course
 - --Two new board makers are working well
