- 1. Apologies for absence John Portwood (Chief Tournament Director)
- 2. Minutes of the last meeting These were accepted as a true record
- 3. Matters arising There was some discussion re. the Deane Salver Complaint from February. It was agreed that by the next f2f committee meeting the procedure for addressing complaints would be looked into and the process already in place would be checked to see if it could be improved. Garden Cities Brunton who had qualified to play in this event had been unable to put a team forward and Darlington who were 2nd would now go forward and represent NEBA in this competition. Corwen Trophy this is still in hand. Pachabo the winning team from the Kempson Vases have yet to confirm if they will play in this competition.
- 4. Continuation of Exec. members David Gold has expressed a wish to stand down at the next A.G.M. he was thanked for all his hard work in the past and now a new Chief Tournament Secretary will be sought.
- 5. N.E.B.A. competitions There was a discussion about whether an earlier start time for competitions i.e. 1pm instead of 2pm might encourage more entries so the finish time is earlier giving people more time to get home before nightfall. Also it was asked whether the entry forms could have more information on them . Giving an approx. number of boards , what refreshments are available, tea break or not, approx.. finish time.
